### **Chairperson's Report**

I'm writing this as I sit in our Genealogy Rooms and look around at all our records. I hope you, as members, realise what a plethora of information we hold down here in our library. If you've never been here for a good look around, it's time you came!

We concentrate on New Plymouth records, but also have Taranaki-wide information, like school admission records, some birth, deaths & marriages and cemetery records. We are open on Saturday morning and Monday morning, 10am to 12:00.

To make things easier to find we have our large biographical index where you can look up people by name and see what records we are holding for them and their families.

This week I am giving a Power Point talk about wills and how important they are for your research. Some are more helpful than others, but you are sure to learn something from each one you see.

I have a will from 1652 for my 8x great grandfather! Before I started writing this talk I had forgotten I had it, but it is full of so much information. This, in turn helps put some of the meat on the bones of that particular family. The tone of the will, what he leaves different people and the measures he takes to make sure his wife is taken care of give an insight into what sort of man he was. It also states he was sick and that was why he was writing the will. And of course, it shows how wealthy he was — or wasn't.

I've even had a will from the time of Queen Elizabeth the 1<sup>st</sup>. It wasn't hers of course, but of an Equerry who was on her staff. It was fabulous to have found something so old still existing – it was written half in latin, so that made transcribing it interesting to say the least, and I learnt a new skill in doing so. Unfortunately I also learned he wasn't related to me later.

So, on Tuesday night, come along and find out what I'm talking about – wills are mines of information. It is very satisfying to work out what the old script says and discover more about your ancestor.

On a different note we are now heading at great speed towards the end of the year. We plan to have our Christmas pot luck lunch as we have for the past couple of years. The date escapes me at the moment but we will let you know in plenty of time.



Our society has invested in ten new books. These are to be added to our Society library. These books have been selected to provide new and up to date reference material, on topics that our members can use for their research.


Details for each book are provided below, with a narrative by Russell Smith.

### A Guide to Tracing Your Family History Using the CENSUS

By Emma Jolly

- Covers England, Scotland, Wales, Ireland, The Channel Islands and The Isle of Man
- Offers detailed expert advice on how to explore and interpret census records
- Covers the latest census records to become available on line
- A valuable guide for the local as well as the family historian

THE CENSUS is an essential survey of our population, and is a source of basic information for local and national government and for all sorts of organizations dealing with education, housing, health and transport. It also



provides the researcher with a fascinating insight into who we were in the past, and that is why Emma Joll's new handbook is such a useful tool for anyone who is keen to find out about their family history. The coverage is detailed, accessible and authoritative, and it is full of advice on how to explore and get the most from the records.

Each census from 1841 to 1911 is described in detail, and late censuses are analysed too. The main focus is on the census in England and Wales, but censuses in Scotland, Ireland, the Channel Islands and the Isle of Man are all examined and the differences explained. Particular emphasis is placed on the rapidly expanding number of websites that offer census information and make the process of research so much easier to carry out. There is an extensive appendix that gathers together all the key resources in one place.


Emma Jolly's guide is an ideal introduction and tool for anyone who is reaching the life and times of an ancestor.

### **DNA - A Guide For Family Historians**

Edited by Graham S. Holton

DNA research is one of the most important and rapidly advancing areas in modern science and the practical use of DNA testing in genealogy is one of its most exciting applications. This accessible, wide-ranging introduction, the first British publication in this field, has been revised in a completely new edition with new topics and illustrative case studies. It offers a clear and practical way into the subject, explaining the scientific discoveries and techniques and how it can be used by genealogists to gain an insight into their ancestry.



The subject is complex and perhaps difficult for traditional genealogists to understand but, with the aid of this book, novices who are keen to take advantage of it will be able to interpret test results and use them to help answer genealogical questions which cannot be answered by documentary evidence lone. It will also appeal to those with some experience in the field because it places the practical application of genetic genealogy within a wider context, highlighting its role as a genealogical tool and suggesting how it can be made more effective.


### **Poor Law Records for Family Historians**

By Simon Fowler

Poor Law Records are the most important records of a parish after the parish registers. Through them we can discover ancestors who were "paupers" who were helped through the Poor Law as well as ancestors who were Poor Law officers.

The Old Poor Law 1601-1834 includes the records of the Parish Overseers of the Poor who were concerned not only with relieving the poor but with matters of settlement, removal, vagrancy, bastardy and apprenticeship.

The New Poor Law 1834-1948 includes the records of the Poor Law Unions with their workhouses before the introduction of the old age pensions and the Welfare State in the twentieth century.



In this book, Simon Fowler describes many of the Poor Law records that may survive and where to find them as well as those of other organisations who helped to relieve families in desperate need.





His book is an essential introduction and source of reference for anyone who is keen to trace their Irish roots.




### **Tracing Your LONDON Ancestors - A Guide For Family Historians**

He looks at the military and wartime records available in the city, and at the records of immigrant communities who have had such a notable impact on the development of the capital.





## Bound For Australia – A Guide to The Records of Transported Convicts and Early Settlers

From the arrival of the first 778 convicts in 1788, to the end of transportation in 1864, a staggering 165,000 criminals were sent to Australia for a range of crimes. In addition to those transported, hundreds of thousands of free persons emigrated from Britain and Ireland to colonies in Australia. Because of the vast distance involved, few returned, and the descendants of many of them now live in Australia.

Tracing those ancestors today may seem like a daunting task, with The National Archives alone holding over 100 miles of shelving for historical




